REQUEST FOR INFORMATION RELATED TO THE SELECTION OF THE ONE STOP OPERATOR FOR THE NORTHEAST LOCAL WORKFORCE DEVELOPMENT AREA

The Northeast Local Workforce Development Board issues this requirement of information (RFI) to gather information from organizations interested in being operators of the Southeast One Stop Center – AJC. The municipalities to be served by the Operator include: Canóvanas, Ceiba, Culebra, Fajardo, Loíza, Luquillo, Naguabo, Rio Grande y Vieques, in Puerto Rico. Responding this RFI is optional. It is not required for an organization to respond to this RFI to submit a Proposal through an RFP that will be released for the procurement process of the One Stop Operator. The data submitted will not be considered during the operator's evaluation process.

The operator can be a single entity or a consortium of entities which must include a minimum of three of the mandate WIOA partners, a public, private, non-profit organization, with experience and a history of success that can be corroborated. The types of entities that can be operators of the CGU-AJC include:

An Institution of higher education;

- a) An Employment Service State Agency established under the Wagner-Peyser Act;
- b) A private non-profit organization (including community-based organizations);
- c) A Private for-profit entity;
- d) A Government agency;
- e) Another interested organization or entity capable of carrying out the duties of the Operator. Examples of this may be business organizations or labor organizations.
- f) Non-traditional public secondary schools such as: night schools, adult schools or technical schools.

Exception: Elementary or secondary schools are not eligible to be One Stop Center -AJC Operators.

The estimated budget for the next program year, in relation to the funds of the youth, adults, and dislocated workers programs is \$6,427,591.00. This includes administrative/operational costs and costs related to the services offered to participants. The estimate for the operations costs will be stated in the RFP. The budget varies every year, taking into consideration the allocation approved by the United States Congress.
