



**PUBLIC NOTICE**  
**FOR THE SELECTION OF THE ONE STOP OPERATOR FOR THE NORTHEAST**  
**LOCALWORKFORCE INVESTMENT AREA**

The Northeast Local Workforce Development Board hereby informs the public of its intention to select the *Operator for their One Stop Center (OSC)*, in accordance with section 121(d) of the Workforce Innovation and Opportunity Act (WIOA), sections 678.600 - 678.630 of the Final Rule (20 CFR), Training and Employment Guide Letter (TEGL) number 15-16 and the Circular Letter number 02-2017.

The entire procurement process must be performed through a procedure that promotes fairness, openness, transparency, and responsibility from the planning phase to the closeout phase. Among the duties of the OSC Operator there is the coordination of services from the required partners and the providers.

The Operator can be a single entity or a consortium of entities which must include a minimum of three of the mandate WIOA partners, a public, private, non-profit organization, with experience and a history of success that can be corroborated.

The following entities can be an Operator for the One Stop Center:

- a. An Institution of higher education.
- b. An Employment Service State Agency established under the Wagner-Peyser Act.
- c. A private non-profit organization (including community-based organizations).
- d. A Private for-profit entity.
- e. A Government agency.
- f. Another interested organization or entity capable of carrying out the duties of the Operator. Examples of this may be business organizations or labor organizations.
- g. Non-traditional public secondary schools such as: night schools, adult schools or technical schools.

Copies of the Requirement for the Submission of Proposals for the OSC Operator, will be available from Monday to Friday, 8:00 am to 3:30pm, at the office of the Local Board.
